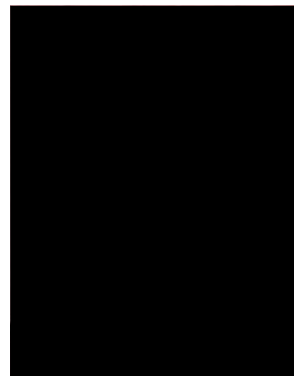

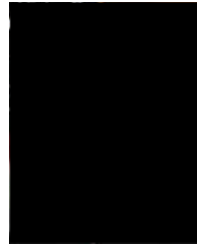

Professionals “Rock Out” For a Day of Fun and Learning at the 2010 AGA/ASMC Spring Seminar

On April 14, the AGA Cleveland chapter co-hosted the 2010 AGA/ASMC Spring Seminar. This year’s theme, “ROCK OUT: Redefining Our Common Knowledge, Objectives, Utilizations, and Tactics,” outlined the conference goal of shaping individuals into accountable leaders. With topics such as U.S. financial reform, ethical responsibilities of accountants, fraud detection, stress management and the characteristics of a really great boss; it was difficult to leave the conference without a sense of enlightenment and enthusiasm towards how one person can have such an impact on many. Listed below is a brief synopsis of the workshops presented at this year’s conference:

Defining a Really Great Boss

Our opening keynotes speaker was Dr. Andrew R. Thomas. He described the characteristics of a great boss, and how agents of change can become leaders. Dr. Thomas also explained what managing by accountability means, and that great bosses possess a set of core competencies that set them apart from mere managers.

NASA’s Financial Challenges and Initiatives

Today’s CFO must tackle complex financial issues including implementing effective federal financial management systems, achieving a clean audit opinion and ensuring effective and efficient financial operations while dealing with the problem of reduced resources. At this workshop, a panel of top financial leaders from the NASA Glenn Research Center discussed these issues along with the financial challenges and initiatives at NASA, and some excellent lessons learned that can be used in other government agencies.

Pension Maximization Plans

The importance of preparing your estate plan as you reach retirement is critical. At this workshop, Scott Tucheck and Bill Schultz discussed its importance and described ways to maximize retirement and pension benefits through the use of insurance.

A Tale of Two Thieves

Randall J. Meyer from the Ohio Auditor of State office told a story of two simultaneous thefts that occurred in one small village, how the funds were diverted, and examples of evidence used to detect the fraud.

Shared Services

Bob Bilbrey and Lee Krushinski from Booz Allen Hamilton spoke to our group about shared services, such as new organizations, new Centers of Excellence and consolidated operations, and the top mistakes to avoid when implementing this type of business model. This workshop displayed the importance of shared services and the fact that the preparation and planning for this type of business model is the key to achieving desired results of high-quality services and cost-effective processing.

It’s About Time! Strategies for a Stress-Free Day

The conference lunch speaker, Traci Miller, the Growth Coach, helped increase participants’ knowledge on how to create effective To-Do lists and increase their willingness to start creating new effective habits in both their work and home lives.

The “Dirty Dozen” Tax Scams

Gary L. Gruver, IRS Special Agent, covered various different tax scams, how they were detected, and what could have been done to prevent them.

U.S. Financial Reform: A Former Regulator’s View

Dr. Kevin Jacques from Baldwin-Wallace College offered his perspective on the financial crisis we are facing today, its causes and effects, and our government’s response.

When is a Partnership Not a Partnership?

Ben Feuts, from the Small Business/Small Enterprise Division of the IRS spoke to the group about the advantages and disadvantages of various small business designations.

Ethical Responsibilities for Accountants

The conference’s closing keynote speaker, Attorney Steve A. Martin, CPA from MDS CPA Review, covered what it takes to be an ethical accountant in today’s accounting field.

Fitness as a Lifestyle: Eating Out while on a Diet Plan

Most people think that dieting is almost like a prison sentence. You can't eat whatever you want and dining out is not an option because of all the temptation. Well, they're wrong. You definitely can still dine out while you're on a diet. And that's without cheating on your diet too! Lunch, dinner, whatever it is that you're dining out for, just make sure to make smart choices. That's the secret! Don't even start thinking that you can binge on not-so-good-for-you foods just because you're dining out. If you truly, seriously and genuinely want to lose weight and keep it off, make sure to stick to your healthy eating habits and make smart choices when you're out at restaurants. You don't have to avoid going out for food at all! Instead, enjoy restaurants while you're working to lose weight and here are some rules that will help you to stick to your weight loss program while dining out:

Lunch invitations:

Lunch invitations are great as this is the best time to eat without damaging the diet or the metabolism

Rule 1: Choose foods from the menu which you truly enjoy and avoid filling your plate with unnecessary side helpings.

Rule 2: Eat slowly and enjoy the food flavors, texture and taste.

Rule 3: Avoid food that looks unhealthy like maida (white flour) products (nan, white bread), deep fried foods and very oily vegetables.

Dinners with family/friends at restaurants:

Rule 1: Begin with a clear soup with vegetables or a combination of chicken and vegetables. Ask the Chef to sauté some vegetables like some exotic Chinese greens, flavored with herbs and spices, in olive oil and accompany this with a salad. You can also have a combination of chicken with marinated vegetables. Vegetarians can ask for cottage cheese in small quantities with marinated greens and a tangy dressing.

Rule 2: Avoid cereals/pulses late night.

Rule 3: Eat slowly enjoying the flavors as it prevents overeating.

Rule 4: Do not wistfully eye other foods on the table as it will invoke sympathy towards you and even family will be forced to offer the heavy foods to you.

Rule 5: Enjoy the ambience, conversation and the moments with the family/friends instead of feeling sorry for yourself!

Late night social occasions:

Rule 1: Only tell your close friends/well wishers that you are on a diet while dining out or it becomes a great ego war, where the host will insist on serving you every conceivable item on the menu till you finally give up!

Rule 2: Eat a snack at 6 pm before you leave because no dinner is served till 11 pm and by that time most people are starving to death. As a result, they end up eating large quantities.
